

**Minutes of Meeting of the Screening Committee held on 28.11.2019 for Selection of New Proposals of Projects under the Scheme of Assistance for Prevention of Alcoholism and Substance (Drugs) Abuse**

The meeting of the Screening Committee of Social Defence Bureau was held on 28<sup>th</sup> November, 2019 under the Chairpersonship of Joint Secretary (SD) to consider the new proposals received from the States/UTs duly recommended by the State Level Committee under the Scheme Assistance for Prevention of Alcoholism and Substance (Drugs) Abuse.

2. Following members of the Screening Committee attended the meeting:

- (i) Sh. S. Prakash from Manav Charities - Member
- (ii) Dr. Monika Pant - Member
- (iii) Shri S.S. Kumar, Dy. Secretary (IFD), M/o SJE - Member

Director (DP), Deputy Secretary (DP) and Under Secretary (DP) of the Ministry were also present in the meeting to assist the committee.

3. The Committee examined all the 37 proposals received online during the period from 06.08.2019 (the date of last meeting of Screening Committee) to 27.11.2019. Gist of all the 37 proposals is at Annexure-I. Taking into consideration the Scheme Guidelines, it was decided that the new proposals should be considered only from un-served areas subject to fulfilment of all the conditions and submission of the required documents by the applicant organizations.

4. After scrutinizing the proposals on the basis of the Scheme Guidelines, the Committee recommended the following 12 proposals for financial support for setting up of new Integrated Rehabilitation Centres for (Drug) Addicts (IRCA):-






