The following are the important activities of the Department of Social Justice and Empowerment during October, 2017:

## Activities of the Department

(i) A Commission comprising the Chairperson, three Members and Secretary has been constituted under Article 340 of the Constitution on 02/10/2017 to examine the issue of Sub-categorization within Other Backward Classes for the Central List. The Chairperson assumed the charge on 11/10/2017 and the Commission has began interactions with the State Government/UT Administrations and the Backward Classes Commission of the States.

(ii) Hon'ble Minister, Social Justice and Empowerment flagged off the Senior Citizens Walkathon organized on 02/10/2017 at Rajpath, India Gate, New Delhi.

(iii) The Hon'ble President of India conferred Vayoshreshtha Samman-National Awards 2017 to the institutions/individuals working in the field of Ageing on 09/10/2017 at Vigyan Bhawan, New Delhi.

(iv) Dr. Ambedkar Foundation organized a Prize Distribution Function on Dr. Ambedkar Foundation National Essay Competition, 2016 for Students of recognized Schools, Colleges, Universities and Institutions on 11/10/2017 at Vigyan Bhawan, New Delhi.

(v) Meetings of the Project Monitoring Committee to review the progress of construction of Dr. Ambedkar National Memorial at 26 Alipur Road, New Delhi, were held on 05/10/2017, 10/10/2017 and 30/10/2017.

## **Activities of Corporations**

(i) National Scheduled Caste Finance Development Corporation (NSFDC) signed Memorandum of Understanding with Telangana Grameena Bank (TGB) & Apollo Med Skills Limited, Hyderabad for imparting assured job placement linked long term vocational courses in Healthcare Sector through Apollo Med Skills with loan under NSFDC's Vocational Education & Training Loan Scheme provided by TGB on refinance mode.
