Sir,

I am directed to say that it has been brought to the notice of this Ministry that members of
Scheduled Castes who have embraced Buddhism are facing difficulties in obtaining Scheduled
Caste certificates.

2. Attention is invited to Ministry of Welfare's letter No. 12016/28/90-SCD (R.L.Cell) dated
20.11.1990 (copy enclosed) addressed to the Secretary, Social Welfare Department / Department
dealing with Welfare of Scheduled Castes of all the State Governments/ Union Territory
Administrations wherein it was clarified that with the enactment of the Constitution (Scheduled
Castes) Orders (Amendment) Act, 1990, the members of Scheduled Caste communities who have
embraced Buddhism shall be deemed to be member of Scheduled Caste. While issuing the
Scheduled Caste certificates to these persons, the same procedure has to be followed as applicable
to the members of other Scheduled Caste communities belonging to the Hindu and the Sikh
religions and the form of caste certificate will also remain the same as applicable to other
Scheduled Caste communities.

3. All the State Governments/U.T Administrations are, again requested to follow the
procedure mentioned in Ministry of Welfare's letter dated 20.11.1990 for issuing caste certificate
to the Scheduled Caste persons professing Buddhist religion.

Sir,

In continuation of this Ministry's letter of even number, dated 31st July 1990, on the above subject, I am directed to say that with the amendment of Constitution (Scheduled Castes) Order 1950 by the Constitution (Scheduled Castes)Orders(Amendment)Act, 1990, the Scheduled Caste communities which are included in the Presidential orders and converted to Buddhist region shall be deemed to be a member of Scheduled Caste.

2. While issuing the Scheduled caste certificates to these persons, the same procedure has to be followed as applicable to the members of other Scheduled caste communities belong to Hindu and Sikh religions.

3. The form of caste certificate will also remain the same as applicable to other Scheduled Caste communities (Annexure).

4. All the State Governments/U.T Administrations are, therefore requested to follow the above procedure for issuing Scheduled Caste certificate to the persons professing Buddhist religion provided:

- (a) the name of the community for which Scheduled Caste certificate is to be issued is included in the Presidential Orders specifying the Scheduled Caste in relation to the concerned State/Union Territory;
- (b) that the person and his parents actually belong to the community claimed;
- (c) that the person belongs to that State and to the area within that State in respect of which the community has been scheduled;
- (d) the person claiming to be a Scheduled Caste professes either the Hindu, Sikh or the Buddhist religion;

5. The certificate issuing authorities may kindly be instructed to make proper verification before issuing such certificates.

Subject: - Difficulties faced by members of Scheduled Castes converted to Buddhism in availing reservation benefits of Central Government and its Public Sector Undertakings.

Sir,

I am directed to refer to your letter No. CBC-2016/CR-151/Mavak dated 21.04.2017 on the subject mentioned above and to say that the request of the State Government to accept their caste certificate format for Scheduled Castes converts to Buddhism has been examined in consultation with Department of Legal Affairs of Ministry of Law and Justice, which has opined that caste certificate format should fulfil the criteria of uniformity, certainty and clarity. The caste certificate format suggested by Government of Maharashtra does not fulfil the above criteria, because it does not mention the name of caste of the certificate holder, rather in it Sl. No. at which a caste appears in the list of Scheduled Castes is indicated which may change over a period of time as has been in the case of Mahar caste of Maharashtra, which appeared at Sl. No. 22 of the list of Scheduled Castes of the then State of Bombay notified on 10.08.1950, whereas, presently, it appears at Sl. No. 37. Further, it is against the parameter of uniformity as rest of the States and Union territories are following the caste certificate format recommended vide Ministry of Welfare's letter No. 12016/28/90-SCD (R.L.Cell) dated 20.11.1990 (copy enclosed).

2. It is, therefore, requested that the authorities empowered to issue caste certificate in the State of Maharashtra be directed to follow the caste certificate format circulated vide Ministry of Welfare's letter dated 20.11.1990 so that members of Scheduled Caste who have converted to Buddhism do not face difficulties in enjoying reservation benefits of Central Government and Public Sector Undertakings.



The following Act of Parliament received the assent of the President on the 3rd June, 1990, and is hereby published for general information:—

THE CONSTITUTION (SCHEDULED CASTES) ORDERS (AMENDMENT) ACT, 1990

No. 15 OF 1990

[3rd June, 1990.]

An Act further to amend the Constitution (Scheduled Castes) Order, 1950 and the Constitution (Scheduled Castes) (Union Territories) Order, 1951 and to amend the Constitution (Jammu and Kashmir) Scheduled Castes Order, 1956, the Constitution (Dadra and Nagar Haveli) Scheduled Castes Order, 1962, the Constitution (Pondicherry) Scheduled Castes Order, 1964 and the Constitution (Sikkim) Scheduled Castes Order, 1978.

BE it enacted by Parliament in the Forty-first Year of the Republic of India as follows:—

1. This Act may be called the Constitution (Scheduled Castes) Orders (Amendment) Act, 1990.
