

¹THE CONSTITUTION (JAMMU AND KASHMIR) SCHEDULED CASTES ORDER, 1956*

C.O. 52

[This order was initially issued for the then State of Jammu and Kashmir. However, vide s. 65 of Act No. 34 of 2019 it has been made applicable to Union territory of Jammu and Kashmir & Union territory of Ladakh w.e.f. 31.10.2019]

In exercise of the powers conferred by clause (1) of article 341 of the Constitution of India, the President, after consultation with the Sadar-i-Riyasat of Jammu and Kashmir, is pleased to make the following Order, namely: —

1. This Order may be called the Constitution (Jammu and Kashmir) Scheduled Castes Order, 1956.*
2. The castes specified in the Schedule to this Order shall, for the purposes of the Constitution, be deemed to be Scheduled Castes in relation to the State of Jammu and Kashmir:

Provided that no person who professes a religion different from the Hindu ²[, the Sikh or the Buddhist] religion shall be deemed to be a member of a Scheduled Caste.

The following Act of Parliament received the assent of the President on the 3rd June, 1990, and is hereby published for general information:—

THE CONSTITUTION (SCHEDULED CASTES) ORDERS (AMENDMENT) ACT, 1990

No. 15 OF 1990

[3rd June, 1990.]

An Act further to amend the Constitution (Scheduled Castes) Order, 1950 and the Constitution (Scheduled Castes) (Union Territories) Order, 1951 and to amend the Constitution (Jammu and Kashmir) Scheduled Castes Order, 1956, the Constitution (Dadra and Nagar Haveli) Scheduled Castes Order, 1962, the Constitution (Pondicherry) Scheduled Castes Order, 1964 and the Constitution (Sikkim) Scheduled Castes Order, 1978.

BE it enacted by Parliament in the Forty-first Year of the Republic of India as follows:—

1. This Act may be called the Constitution (Scheduled Castes) Orders (Amendment) Act, 1990.
