### **ORDER**

Whereas this Ministry *vide* Notification No. AG-15039/37/2021-Sr.C-I dated 12.07.2021 invited applications from eligible organizations for gap districts for running projects under Integrated Programme for Senior Citizens (IPSrC) [a scheme under Atal Vayo Abhyuday Yojana (AVYAY)].


2. And whereas as per Section A.3(iii) of the Scheme guidelines, applications received from the organizations are to be assessed and Implementing Agency is to be finalized by a Screening Committee constituted in this Department. And whereas the said finalization of an Implementing Agency for a project shall be on the basis of recommendation by the Selection Committee at the respective State/ UT level. And whereas in response to the Notification referred above recommendations have been received from Selection Committees of Karnataka and Mizoram only.

3. On the basis of screening committee report dated 27.01.2022 and further approval of competent authority, following organizations have been finalized as implementing agencies under IPSrC :-
