MINUTES OF THE MEETING OF THE SCREENING COMMITTEE FOR THE RECOMMENDATION OF ONE SUITABLE CANDIDATE FOR THE POST OF MULTITASKING (NON-TECHNICAL) STAFF UNDER COMPASSIONATE APPOINTMENT QUOTA IN THIS MINISTRY HELD ON 20.08.2025 IN THE ROOM OF DIRECTOR-CUM-CHAIRMAN OF THE SCREENING COMMITTEE, SHASTRI BHAWAN, NEW DELHI-01.

In terms of DoP&T's O.M No.14014/1/2022-Estt.(D) dated 02.08.2022, this Ministry has earmarked one vacancy of Multi-Tasking (Non-Technical) Staff to be filled up through Compassionate appointment quota. The assessment of applications for appointment on compassionate grounds shall be carried out on the basis of the Relative Merit Point System, on a scale of 100 points.

- 2. The details of seventeen (17) applicants based on the records available in the Establishment section who have applied for the post of Multi-Tasking (Non-Technical) Staff under Compassionate appointment Quota in this Ministry is at **Annexure-I**.
- 3. It has been informed that Shri Surender Ahlawat did not submit the requisite details despite repeated reminders. Further, the details in respect of Shri Ayush and Shri Shubham bali has yet to be finalized by the department Consequently, their case has not been considered for appointment to the post of MTS under the Compassionate Appointment quota in this Ministry during the current cycle.
- 4. The Welfare Officer has submitted the Inspection report to the Department after consultation with all the applicants and requested to re-verify the figures in respect of Family pension and Terminal benefits from Estt./Cash section of the Department.
- 5. The consolidated points on a scale of 100 points to the fourteen (14) applicants based on Inspection report by the Welfare Officer and data by PA&O and cash section is at **Annexure II.**

- 6. The committee was apprised that most of the applicants have crossed the prescribed upper age limit for the post of Multi-Tasking (Non-Technical) Staff. Therefore, it was advised that the competent authority may grant relaxation in upper age limit to the selected candidate in terms of DoP&T guidelines on compassionate appointment or the extant rules in this matter.
- 7. The Screening Committee examined all the cases in detail and deliberated upon each of them. Based on the consolidated points allocated at **Annexure-II**, the Committee has recommended the following candidate as eligible for appointment to the post of Multi-Tasking (Non-Technical) Staff in this Ministry under Compassionate appointment quota:
