ORDER

WHEREAS Haryana Nav Yuvak Kala Sangham has been receiving Grant-in-aid under the Scheme of Integrated Programme for Senior Citizens (IPSrC) from this Ministry for running and maintenance of Senior Citizen Home for 25 beneficiaries at VPO Mohra(Ambala), Haryana-133004.

- 2. AND WHEREAS the project of "Senior Citizen Home" which is being run by the organization with financial assistance from this Ministry under the IPSrC Scheme has been violating the scheme guidelines.
- 3. AND WHEREAS the Organisation had been receiving GIA for its projects at Gurgaon, Karnal and Kurukshetra. The GIA had been cancelled after examination of the negative inspection reports and explanations submitted by the NGO for the respective projects.
- 4. AND WHEREAS at the time of surprise inspection dated 17.11.2023 of the project at Ambala, it had been observed by the PMU team that the project is non-functional. There was no staff personnel or beneficiary present at the location of the project. Office was closed.
- 5. AND WHEREAS the project was served Show Cause Noticesdated 02.05.2024 and 21.05.2024. But since there was no recipient at the registered address of the NGO as well as at the project location, the letters were not delivered.
- 6. Now therefore, after considering all the facts of the matter and going into details of the case, it is noted that the Organisation has been found violating the guidelines of Atal Vayo Abhudyay Yojana, which is a serious lapse, the Organisation namely Haryana Nav Yuvak Kala Sangham, Haryana is hereby blacklisted for receiving further grant-in-aid from the Government of India.
- This issues with the approval of the Competent Authority.
