VACANCY CIRCULAR

Sub: Procedure and guidelines for engagement/hiring of 05 Research Associate (Consultant) at Dr. Ambedkar International Centre – reg.

- 1. Dr. Ambedkar International Centre is an autonomous body under the aegis of Ministry of Social Justice & Empowerment. DAIC invites application for engagement / filling up the post of 05 Research Associate on contractual basis at Dr. Ambedkar International Centre, Department of Social Justice and Empowerment, New Delhi from suitable candidates who fulfill the eligibility conditions, meet the qualification, age etc as noted below:-
- 2. **Terms of Engagement**: The Research Associate (Consultant) will be purely hired on a contractual basis for a period of one year. The appointment of Research Associate (Consultant) is of a temporary nature and incumbent not claim regularization of services any point of time.

3. Essential Educational Qualification:-

(a) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a Social Sciences/ Law/Economics/ Governance Policy and concerned/ relevant/ allied subject from an Indian University, or an equivalent degree from an accredited foreign university.

Desirable Qualification:-

- (a) The applicant should hold a Ph.D. degree in the above discipline from the recognized university.
- (b) The Candidate has published minimum three research papers from his/her Ph.D. work, in a refereed journal of UGC Care List or Scopus Listed Journal.
- (c) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/ seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.
- (d) Minimum three years research experiences in the field of Socio-economic transformation, Sustainable Development, Buddhist Studies and other relevant discipline of Social Sciences/Law/Economics/Governance Policy and concerned/ relevant/ allied subject.
- (e) Knowledge of statics and other statistical tool.
- (f) Preference will be given to the candidates who have JRF or recipient of other academic Fellowship experiences, merits of academic credential and publication of policy documents etc.
- 4. **Age:** Not exceeding 40 years as on 28.02.2025.
- 5. **Nationality**: Only Indian Nationals are eligible to apply.

- 6. **Consolidated Consultancy Fee**: All inclusive remuneration shall be Rs.70,000/- (Rupees Seventy Thousand only) per month. The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which this office will issue TDS Certificate/s.
- 7. **Other Allowances:-** No TA/DA shall be admissible for joining the assignment or on its completion. No other allowances or perquisites whatsoever like accommodation, residential phone, conveyance / transport, foreign travel, personal staff, medical reimbursement etc. would be admissible to The Research Associate (Consultant).
- **8.** <u>Leave</u>:- Research Associate (Consultant) shall be eligible for 8 days' leave in a calendar year on pro-rata basis. Therefore, a Research Associate (Consultant) shall not draw any remuneration in case of his /her absence beyond 8 days in a year (calculated on a pro-rata basis). Also un-availed leave in a calendar year cannot be carried forward to next calendar year.
