
- The Ministries or Departments of the Government of India and their autonomous organizations.

- Members of the National Council of Senior Citizens (NCSrC).
- Renowned Apex Chambers like Federation of Indian Chambers of Commerce and Industry (FICCI), Confederation of Indian Industry (CII), Associated Chamber of Commerce and Industry (ASSOCHAM), National Association of Software and Service Companies, PHD Chamber of Commerce and Industry etc.
- Any other category of persons or institutions authorized by the Ministry from time to time.

Nominations in the prescribed proforma complete in all respects with the requisite supporting documents of the nominee, photograph and bio-data of the nominee (in the case of individual category), are to be uploaded on <https://awards.gov.in>. 6. The last date for receipt of nominations is 19th August, 2022. Self-nominations and applications from individuals or institutions not recommended by the prescribed agencies/individuals shall not be entertained and shall be liable to be summarily rejected.

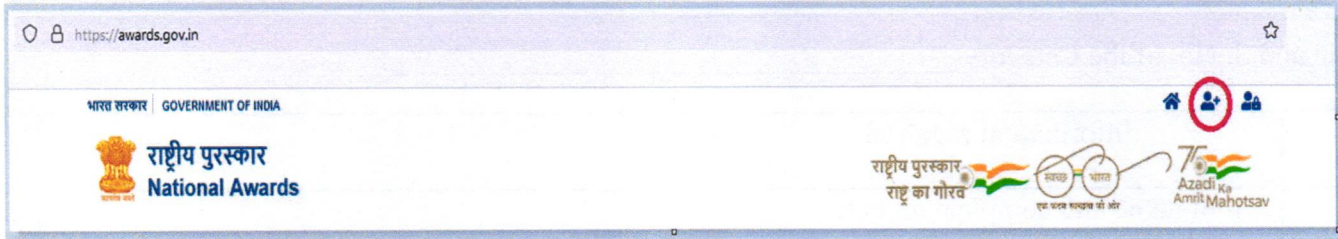

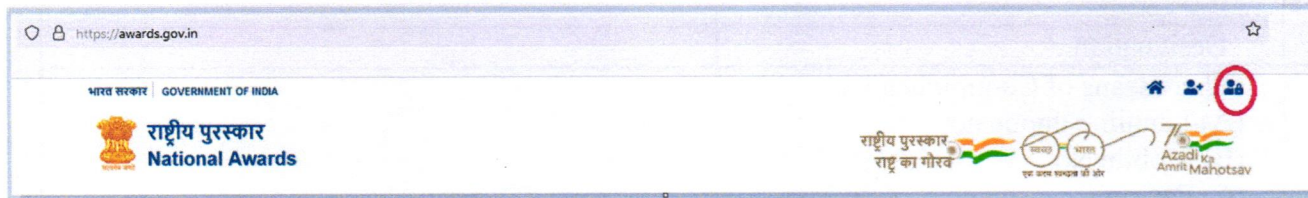
