- (a) (i) Holding analogous posts on regular basis; or
 - (ii) with 2 years regular service in posts with Pay Band- 2 & Grade Pay Rs. 4800/-; or
 - (iii) with 3 years regular service in posts with Pay Band- 2 & Grade Pay Rs. 4600/-; or
 - (iv) with 8 years regular service in posts with Pay Band- 2 & Grade Pay Rs. 4200/-; and possessing the following essential qualifications:
 - (i) Master's degree of a recognized University or Institution in Anthropology or Sociology or Social Work.
 - (ii) 3 years experience of Social Research or Social Planning or Social work, education and training or in the field of social welfare and development in Central /or State Government/Union Territories/Universities/Recognized Research Institutions/Autonomous/Semi Government or Statutory organization/Public Sector Undertaking.

Desirable:

- (i) Doctorate in Social Sciences subject;
- (ii) 2 Years experience of applying statistical methods and research methodology.

<u>Note</u> – The departmental Research Investigators in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed 3 years and shall be governed by the usual/existing terms and conditions of deputat on as laid down by the Government of India.

Selected candidates will not be allowed to withdraw their nominations. Applications received after the prescribed date and/or found incomplete in any respect shall not be considered. No advance copy of application shall be entertained.
