**ORDER**

WHEREAS Chaubisee Vikas Sangh has been receiving Grant-in-aid under the Scheme of Integrated Programme for Senior Citizens (IPsRC) from this Ministry for running and maintenance of the project at Ground Floor, Near Mahle Pali House Siman, Old Society Wali Main Gali, Rohtak, Haryana-124112.

2. AND WHEREAS project of "Senior Citizen Home" of the above organization, which is being run by the organization with financial assistance from this Ministry under the IPsRC Scheme has been violating the scheme guidelines.

3. AND WHEREAS the project was cancelled vide Order dated 26.10.2020 upon detailed examination of negative inspection report of PMU dated 13.08.2020 and unsatisfactory reply of NGO to the Show Cause Notice issued. Whereas the project was reinspected on 30.08.2022 and it was further non-recommended by the PMU team. But keeping a sympathetic view w.r.t. beneficiaries the project was revived vide order dated 21.12.2022.

4. AND WHEREAS at the time of surprise inspection dated 17.11.2023 after revival of the project, it had been again observed by the PMU team that the project is not functional. Glaring deficiencies had been found again at the time of inspection.

5. AND WHEREAS the project was served Show Cause Notices dated 02.05.2024 and 21.05.2024. But since there was no recipient at the registered address of the NGO as well as at the project location, the letters were not delivered.

6. Now therefore, after considering all the facts of the matter and going into details of the case, it is noted that the Organisation has been found violating the guidelines of Atal Vayo Abhudyay Yojana, which is a serious lapse, the Organisation namely Chaubisee Vikas Sangha, Haryana is hereby blacklisted for receiving further grant-in-aid from the Government of India.

7. This issues with the approval of the Competent Authority.
