
Clarifications in response to queries raised in Pre-Bid meeting held on 28th July,2017 at 11.00AM at Shastri Bhawan are tabulated below:

	Queries	Clarifications provided by D/o Social Justice & Empowerment
1.	Availability of data on manual scavengers, Sample size of the proposed study, coverage of study across states, and scope of the study.	<p>I. In the case of U.P where beneficiaries are nearly 11,000, sample size of at least 13% of the total beneficiaries as indicated in the tender document may be taken. For all other states, the total universe would need to be covered.</p> <p>II. In case of UP, 5 most populous districts viz. Moradabad, J.P Nagar, Bijnor, Rampur and Sambhal may be covered for sampling purposes. The samples drawn may have a fair coverage of rural and urban areas.</p> <p>III. The evaluation is to be done in context of rehabilitation of the manual scavengers. Therefore it should cover evaluation of one time cash assistance, loans and skill development provided to the manual scavengers and their family.</p> <p>IV. State wise details of beneficiaries* that have received OTCA upto June 2017 to be used for identification of beneficiaries. (uploaded at http://socialjustice.nic.in/)</p> <p>V. Skill training institutes who are imparting training for Manual Scavengers would be assessed. List of such institutes uploaded on http://socialjustice.nic.in/).</p> <p>VI. Scheme guidelines and SRMS Act uploaded on http://www.mssurvey.nic.in/.</p> <p>VII. Address and other details of Manual Scavengers are available on website http://mssurvey.nic.in</p>

2.	Whether an Organisation can form a Consortium & Bid	The Organisation may bid as a Consortium but the members of the Consortium would not be permitted to bid as individual entities also. The Lead Member who would represent the Consortium for all future transactions with the Department in the event of acceptance of the bid may be identified upfront.
3.	The amount of review time given by the Department with respect to delay in submission of report.	The duration of the study is three months. The draft report would need to be submitted by the Organisation within this three month deadline. Prior to this, a presentation on the preliminary findings would be required to facilitate mid course corrections if any. Time taken by the Department for examining and accepting the Report would not attract penal provisions @ 0.5% of cost per week.
