Registered Companies and Societies having more than 75% shareholding by Scheduled Caste entrepreneurs/promoters/members with managements control for past 12 months.	Registered Companies, Societies, Partnership firms and Sole Proprietorship firms having more than 75% shareholding by Scheduled Castes entrepreneurs/promoters/members with management control for past 12 months.

- It is imperative that the aforesaid modification may be brought with immediate effect and adequately publicized for better coverage under the Scheme.
- This issues with approval of the Competent Authority.
