VACANCY CIRCULAR

Ministry of Social Justice & Empowerment, Department of Social Justice & Empowerment proposes to fill one post of Deputy Secretary in the National Commission for De-notified, Nomadic and Semi Nomadic Tribes (NCDNT) from amongst the officers of the Central/State Government/ Autonomous Bodies/Institutes including officers of the Central Secretariat Service in the Ministries/Departments of the Government of India or from open market, **on deputation basis**. Office of NCDNT is located at 9th Floor, Jeevan Prakash Building, 25 K.G. Marg, New Delhi – 110001.

2. The selected officer will be on deputation upto January 2018 initially, which can be curtailed or extended further, depending upon the requirement, and with the consent of the officer and approval of the lending Ministry/Department, wherever applicable.

3. In the above Pay band, the pay of the candidate selected for appointment on deputation basis would be fixed according to DoPT's guidelines on the subject.

4. Eligible applicants who wish to apply for the above post may submit their Application in the prescribed proforma Annexure-A. In case of Applicants who are working under Central Government or an organization under the Central Government, State Governments or an organization under the State Government applying for this post may get their applications routed through proper channel along with Vigilance Clearance (Annexure-1), Integrity Certificate (Annexure-2) and No Penalty Certificate (Annexure-3). Applications for the above said post may be sent to the undersigned, **latest by 27th March, 2017.**



5. Decision of the Selection Committee for appointment to the above post on deputation basis will be final and binding on all Applicants.

Note 1: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the, Central Government shall ordinarily not to exceed three years.

Note2: The maximum age limit for appointment by deputation as on cut-off is 58 years. The cut-off date for deciding eligibility/experience is 1st April, 2017.

Note 3: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2016 or the date from which the revised pay structure based on the Seventh Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post for which that grade pay or pay scale is the normal replacement grade without any up gradation.
