

**MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 6<sup>th</sup> SEPTEMBER, 2019 TO CONSIDER NEW PROJECT PROPOSALS UNDER THE SCHEME OF INTEGRATED PROGRAMME FOR SENIOR CITIZENS (IPSrC) FOR THE YEAR 2018-19.**


The meeting of the Screening Committee of Social Defence Bureau was held on 6<sup>th</sup> September, 2019 under the Chairpersonship of Joint Secretary (SD) (Ms. Radhika Chakravarthy) to consider the new project proposals duly recommended by the State Level Committee under the Scheme of Integrated Programme for Senior Citizens (IPSrC). Deputy Secretary (Sr.C-I) was asked by the Committee to assist them in the scrutiny during the meeting.

2. The Committee comprising of Shri S.B.Jain as Member and Shri P. K. Tamarkar, Director (IFD), as Member, considered a total of 15 (12 proposals for 2018-19 and 3 proposals for 2019-20) online new project proposals received on or after the previous Screening Committee meeting held on 28/6/2019. Shri Pankaj Kochar, Member did not attend the meeting for personal reasons. Details of the proposals duly recommended by States/UTs Governments received during the above period were placed before the Screening Committee is given in the **Annexure**.


3. The Committee, examined 15 new project proposals, state wise and district wise, and decided that the new project proposals of Senior Citizens Home (Earlier Old Age Homes) should be considered, from uncovered/ un-served districts only, subject to fulfilment of all the conditions and submission of the required documents by the organization, as mentioned in the Scheme.

4. After scrutinizing the proposals received from the State Governments along-with their recommendations, the Committee recommended the following new project proposals of Senior Citizens Homes for 2018-19 and 2019-20 under the Scheme of Integrated Programme for Senior Citizens(IPSrC):-


