MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 23<sup>rd</sup> OCTOBER, 2018 TO CONSIDER NEW PROJECT PROPOSALS <u>UNDER THE SCHEME</u> OF INTEGRATED PROGRAMME FOR OLDER PERSONS (IPOP) (SINCE RENAMED AS INTEGRATED PROGRAMME FOR SENIOR CITIZENS (IPSrC) W.E.F 01/04/2018) FOR LEFT OVER CASES FOR THE YEAR 2016-17, 2017-18 and 2018-19.

The meeting of the Screening Committee of Social Defence Bureau was held on 23<sup>rd</sup> October, 2018 under the Chairmanship of Joint Secretary (SD) to consider total **320** proposals duly recommended by the State Level Committee received from the States/UTs under the Scheme of Integrated Programme for Older Persons (IPOP), now renamed as Integrated Programme for Senior Citizens (IPSrC) w.e.f. 01/4/2018.

- 2. The Meeting was chaired by the Joint Secretary (SD). Members of the Screening Committee, namely, (1) Shri Sriram Gupta and (2) Shri Prakash Tamrakar, Director (Finance), Ministry of Social Justice and Empowerment, attended the meeting. Dr. G. Munirathnam did not attend the meeting.
- 3. At the outset, the Committee Members were briefed about the existing guidelines of the Ministry, norms and guidelines of the revised Scheme, budgetary allocation under the Scheme and number of new proposals received and consideration. Details of proposals State/District-wise, existing districts uncovered etc., were placed before the Committee. The Committee was informed that after the meeting of the Screening Committee held on 10/3/2017, total 81 proposals for 2016-17, 201 proposals for 2017-18 and 38 proposals for 2018-19 were received online in the Ministry under the Scheme of Integrated Programme for Senior Citizens (IPSrC) (Earlier Integrated Programme for Older Persons (IPOP).
- 4. A meeting of the Screening Committee was also held on 18/7/2018 to consider the new project proposals received under the Scheme of IPSrC. However, recommendations of the Screening Committee held on 18/7/2018 could not be accepted as the tenure of the Screening Committee had already expired on 28/6/2018 i.e. well before the date of screening committee meeting. Accordingly, the competent authority has extended the validity of the tenure of the Screening Committee up to 31/10/2018. The Competent Authority has directed that priority should be given to the project proposals of Senior Citizens Home/ Senior Citizens Home for 50 elderly Women in uncovered districts.
- 5. Joint Secretary (Social Defence) and Chairperson of the Committee drew the attention of the Members that as per para 7 (ii) of the Scheme, the NGO should be registered either under the Societies Registration Act, 1860 or relevant State Societies Registration Act and should already be working for at least two years. The Committee after detailed deliberations decided that the eligible proposals of implementing agencies from the un-served Districts may be considered and recommended. Similarly, proposals of Senior Citizens Home/ Senior Citizens Home for 50 elderly women may also be considered and recommended in the un-served Districts i.e. the proposals of SrCH may be considered and recommended in a District in which ongoing project of SrCH for elderly Women is receiving funds and vice-versa. In case, more than one proposal is eligible in particular District(s), preference will be given to the proposal which has been recommended earlier by the respective State Government. If the eligible proposals are recommended by the State Government on same day, then preference will be given to the NGO who had applied earlier.

The Committee also decided that the new proposals under the scheme received from the States of Madhya Pradesh, Chhattisgarh, Rajasthan, Telengana and Mizoram may be considered and recommended. However, grant-in-aid may not be released to such project and no communication should be made by the Ministry with the State Governments or with the implementing agencies till the expiry of Model Code of Conduct in the above-said States. It has also been decided by the Committee that the eligible proposals of SrCH which are not in un-served Dsitricts may not be recommended. Similarly, the proposals for other projects except SrCH such as Regional Resource Training Centre, Respite care Home, Mobile Medicare Unit and Physiotherapy Clinic may not be recommended as priority was given to the project of Senior Citizens Home.
