Result of National Overseas Scholarship for the Selection Year 2016-17

Under the existing scheme of National Overseas Scholarship for the Selection year 2016-17, 98 candidates have already been selected. 10 (Ten) more candidates have been provisionally recommended by the competent authority for the Assurance of Scholarship.

2. 162 candidates who could not be considered earlier owing to incomplete application, non furnishing of information/documents etc. were given another chance to rectify the deficiency observed in their applications. 68 candidates furnished the required information/documents. Accordingly, 68 candidates were considered by screening cum selection committee. After consideration, the committee has provisionally recommended 10 (Ten) candidates for assurance of scholarship under the 5th and final list for Selection Year 2016-17 as per Annexure-1

3. The candidature of the selected candidates is PROVISIONAL subject to they being found eligible in all respects. The candidates would be required to produce the original certificates in support of their claims relating to age, educational qualifications, caste, income etc before actual release of funds. They are, therefore, advised to keep the said certificates ready.

4. Provisional award/assurance letters will be issued to selected candidates shortly. The selection would be confirmed subject to verification of all original documents and fulfilment of the other eligibility requirements like Police verification, Submission of Bonds, Confirmation of admission, accreditation of college/university by Indian Missions abroad etc. as per scheme. The provisional award/assurance letter however, will not bestow any legal right on the candidate to claim the award and the award will be cancelled if any information/documents submitted by candidate is found to be false/incorrect.

5. All documents submitted by provisionally selected candidates are subject to verification for genuineness. If information/document submitted by the candidate is established as false, he/she will be debarred from the award and if he/she has availed scholarship or is availing scholarship, action will be initiated for recovery of the scholarship disbursed with 15% compound interest thereon. Such candidate is also liable to be black listed for future.

6. The committee also recommended to close the selection under National Overseas Scholarship Scheme for the selection year of 2016-17 and to carry forward 83 vacant slots to year 2017-18.
