**National Overseas Scholarship for the Selection Year 2015-16**

On the basis of information furnished by the Candidates in their application forms, the documents submitted with them and taking into consideration the existing guidelines of the scheme of National Overseas Scholarship for the Selection year 2015-16, 30 candidates have been provisionally recommended by the competent authority for the award of Scholarship/Assurance for the selection year 2015-16.

2. **The candidature of these candidates is PROVISIONAL subject to them being found eligible in all respects and confirmation/verification of Income /Caste/Marks & Date of Birth from originals.** The candidates would be required to produce the original certificates in support of their claims relating to age, educational qualifications, caste, income etc before actual award of scholarship. They are, therefore, advised to keep the said original certificates ready.

3. A total number of 132 applications were received within the due date i.e. 04.04.2016.

4. Provisional award/assurance letters will be issued to selected candidates shortly. The selection would be confirmed subject to verification of all original documents and fulfillment of the other eligibility requirements like Police verification, Submission of Bonds , Confirmation of admission, accreditation of college/university by Indian Missions abroad etc. as per scheme guidelines. This provisional award letter will, however, not bestow any legal rights on the candidate to claim the award and the award will be cancelled if any information/documents submitted by candidate are found to be false subsequently.

5. **All documents submitted by provisionally selected candidates are subject to verification for genuineness.** If any candidate has furnished any false information/document and is established as false, he/she will be debarred from the award of scholarship and if he/she has availed scholarship or is availing, action will be initiated for recovery of the scholarship disbursed with 15% compound interest thereon. Such candidate is also liable to be black listed for availing any government scholarship in future.

6. It has been decided that the applicants who had not furnished the required necessary documents with the NOS application are being given a chance to submit the relevant documents to this ministry. A letter will be issued in this regard to all such candidates clearly specifying the requirements and missing documents /information. The applicant has to submit the said documents within 15 days from the date of receipt of such letter failing which, their applications for NOS 2015-16 will thereafter be considered as closed and no further correspondence will be entertained.

7. It has been decided by competent authority not to consider the applications received after 4<sup>th</sup> Apr, 2016 for the year 2015-16 . These applicants are being advised to apply for NOS scholarship for the selection year 2016-17 , when called for .

8. The candidates who have been found ineligible are being suitably intimated with reasons therefore .


