ELIGIBILITY CONDITIONS FOR RECRUITMENT TO THE POST OF STAFF CAR DRIVER (ORDINARY GRADE) IN THE MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT

#### **ESSENTIAL:**

- (i) Posession of a valid driving license for Motor Cars.
- (ii) Have the knowledge of Motor Mechanism (the candidate should be able to remove minor defects in vehicles)
- (iii) Experience of driving a motor car for at least three years.
- (iv) 10<sup>th</sup> Standard Pass.

#### **DESIREABLE:**

Three years service as a Home Guard/Civil Defence Volunteer.

### Armed Forces Personnel:

The Armed Forces Personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. Such persons would be given deputation terms upto the date on which they are due for release from the Armed Forces; thereafter they may be continued on re-employment.

**Note:** The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed 3 years. The maximum age limit for deputation is 56 years on the closing date of receipt of application.
