Estimated cost of machines is worth Rs. 5.00 Lakhs and Earnest Money Deposit (EMD) will be Rs. 15,000/- (Rupees Fifteen Thousand only) in the form of Demant Draft Account Payee or Banker Cheque from any National/Commercial Bank at Delhi in favour of Dr. Ambedkar National Memorial, M/o Social Justice & Empowerment, New Delhi
  - i. No request for transfer of any previous deposit of Earnest Money Deposit or Performance security Deposit or adjustment against any pending bill held by the Department in respect of any previous work shall be entertained.
  - ii. The bid security may be forfeited:
    - If the bidder withdraws his bid during the period of validity of the bids specified by the bidder in the bid form: or
    - In case of successful bidder, if the bidder
      - a) Fails to sign the contract in accordance with the terms of the tender document:
      - b) Fails to furnish required Performance Security Deposit in accordance with the terms of Tender Documents within the time frame specified by the client: or
      - c) Fails or refuses to honour his own quoted prices for the services or part thereof.
- 2. Interested bidders submit their application with a letter written on letter head of the Manufacturer / Supplier. The bidding document can also be downloaded from our website 'socialjustice.nic.in'.
- 3. The cost in the contract agreement will be payable to the supplier.
- 4. Services under this contract will cover printing of special instructions on the label and packing, insurance of the machines, transportation of the machine to the installation site, training the technician about the operation of machines and services and repair of the machine on site.
- 5. On the date of signing the contract, the successful bidder shall furnish the performance guarantee. The performance guarantee will be 5% of the contract amount.
- 6. Failure of the successful bidder to comply with the requirement of DANM, the tender will be awarded to the next lowest evaluated bidder or call for re-bidding.
- 7. The delivery period of the machines will be within 15 days from the date of the purchase order. In case of late delivery, a penalty of 0.1% of the total cost will be imposed every day for one week. After one week the contract shall be deemed as cancelled.
- 8. The supplier of machines shall not disclose the contract documents and information to any person other than the person employed by the supplier.
- 9. DANM or its representative shall have the right to inspect/test the machines to check their conformity to the contract specifications.
- 10. The supplier or the manufacture shall train technicians to operate, loading and unloading of necessary items in machine, collect cash and to prepare a report of any fault in the machine.
- 11. DANM reserves all the right to reject the machine and cancel the bid if the machines fail in the test and inspection both physical and operational.

- 12. The supplier shall have to give operational manuals, service manuals, periodic preventive maintenance manuals and all other necessary literature needed for smooth functioning of the machine.
- 13. The supplier shall provide all incidental services and the cost of such services should be included in the contract.
- 14. A comprehensive Annual maintenance contract of two years for complete system will be provided by the supplier. The payment to the successful order will be made 100% after delivery, installation, testing, inspection and a certificate of fitness of machine both by the supplier and the person/committee appointed by DANM.
- 15. The supplier shall not assign in any case, in whole or in part, subcontract under this contract to any other agency.
- 16. The manufacture should attach a certificate that the after sale services/back up services shall be provided without delay.
- 17. Incomplete bid shall stand rejected.
- 18. No bidder shall contact the procuring agency on any matter related to its bid, from the time of the bid opening to the time the contract is awarded. Any effect by a bidder to influence the procuring agency in its decision on bid evaluation, bid comparison, on contract award will result in rejection of the bid and subsequent black listing. Canvassing by any bidder at any stage of the tender evaluation is strictly prohibited.
- 19. To accept and reject any bid and / or imposing any condition in procurement of machines is decision of Joint Secretary (SCD- A & BC) will be treated as final decision.
