- (C) "Correctional Services National Institute of Social Defence" saving of Rs.205.00 lakhs (against the sanctioned provision of Rs.615.00 lakhs) was due to delay in commencement of the Training Programmes owing to non-indication of actual dates by some of the State Governments / UT Administrations.
- (D) "Assistance to Voluntary Organisations"
 - (a) "Assistance to Voluntary Organisations for Providing Social Defence Services" saving of Rs.179.81 lakhs (against the sanctioned provision of Rs.500.00 lakhs); and
 - (b) "Assistance to Voluntary Organisations for Programmes relating to Aged"- saving of Rs.387.14 lakhs (against the sanctioned provision of Rs.2000.00 lakhs).
 - Savings under the above two heads were due to less receipt of sufficient proposals from the voluntary organisations and non-approval of Anganwadi Projects in three States.

- (A) Major Head "2235"- "Social Welfare-Other Programmes-Handling, Clearance of Duty free consignment under the bi-lateral agreements"-excess of Rs. 136.00 lakhs (against the sanctioned provision of Rs. 400.00 lakhs) was due to receipt of more bills.
- (B) Major Head"3601"-Grants for Centrally Sponsosred Plan Schemes"-
 - (a) "Welfare of Scheduled Castes- Education",
 - (i) "Boys Hostels"- excess of Rs. 499.00 lakhs (against the sanctioned provision of Rs.2650.00 lakhs) was due to re-appropriation of funds from Major head "2552" to functional heads for uitlisation on schemes for the benefit of North Eastern Region and Sikkim.
 - (ii) "Girls Hostels"- excess of Rs. 499.00 lakhs(against the sanctioned provision of Rs. 2350.00 lakhs) due to change in funding pattern under the scheme.
 - (b) "Welfare of Backward Classes Education Boys and Girls Hostels" excess of Rs.274.25 lakhs (against the sanctioned provision of Rs.1780.00 lakhs) was due to requirement of additional funds from State Governments for constructions of hostels.
