
Subject: Withdrawal of blacklisting order of NGO namely 'Samaj Sewa Sansthan' – reg

Sir,

I am directed to refer to your representation dated 07.10.2017 on the above – mentioned subject and to say that the same has been considered by the competent authority. In this context, it is to state that the NGO was blacklisted by this Ministry, vide order of even number, dated 08.11.2017. The competent authority directed to keep the order of blacklisting of NGOs in abeyance and seek report from the State Government. Accordingly, blacklisting was kept in abeyance, vide letter dated 21.02.2018 and the State Government of UP was requested to conduct an inquiry and submit report to this department.


2. Government of UP, vide their letter No. 741/26-2-2018, dated 19.04.2018 submitted a detailed inspection report, along with other supporting documents, to this Ministry. The project site of the NGO was inspected by Social Welfare Officer, Barabanki District on 15.03.2018.

3. The representation of the NGO and the Report of the Government of UP have been considered by this Department and the competent authority has decided to withdraw the blacklisting order of the organization. Accordingly, the blacklisting order of the organization, 'Samaj Sewa Sansthan', Dr B R Ambedkar Hostel, Siddharth Nagar, Faizabad Road Barabanki Pin Code 225001', is hereby withdrawn.
