I am directed to refer to your representation dated 13.10.2017 on the above – mentioned subject and to say that the same has been considered by the competent authority. In this context, it is to state that the NGO was blacklisted by this Ministry, vide order of even number, dated 20.11.2017. The competent authority directed to keep the order of blacklisting of NGOs in abeyance and to seek report from the State Government. Accordingly, blacklisting was kept in abeyance, vide letter dated 21.02.2018 and the State Government of Rajasthan was requested to conduct an inquiry and submit report to this department.

- 2. Government of Rajasthan, vide their letter dated 17.07.2018 submitted a detailed inspection report, along with other supporting documents, to this Ministry. The project site of the NGO was inspected by officers of Govt of Rajasthan on 19.04.2018.
- 3. The representation of the NGO and the Report of the Government of Rajasthan have been considered by this Department and the competent authority has decided to accept the report. Accordingly, the blacklisting order of the organization, Prasasvi Sansthan, 38, Royal Society, Bajrang Nagar, Kota, Rajasthan- 324005, is hereby withdrawn. This issues with the approval of Secretary, D/o SJ&E.
- 4. The organisation is also hereby directed to strictly adhere to the Scheme guidelines and rules of the Govt failing which further GIA may be stopped to the organisation.
