**Result of National Overseas Scholarship for the Selection Year 2017-18
(4th & Final list)**

Under the scheme of National Overseas Scholarship for the Selection year 2017-18, 100 (One Hundred) candidates have been provisionally recommended by the competent authority for the Award/Assurance of Scholarship under 4th and final list on the basis of information furnished by the candidates in the application form and other documents submitted along with it.

2. Total 273 candidates (including 54 candidates who were given chance to rectify the applications under earlier rounds of selection and whose response was received during Selection Year 2017-18) were considered by screening cum selection committee in the Meeting held on 09.05.2018. After consideration, the committee has provisionally recommended 100 (One Hundred) candidates for Award/Assurance of scholarship under the 4th and Final list for Selection Year 2017-18 as per Annexure-1.
3. The candidature of the selected candidates is PROVISIONAL subject to being found eligible in all respects. The candidates would be required to produce the original certificates in support of their claims relating to age, educational qualifications, caste, income etc before actual release of funds. They are, therefore, advised to keep the said certificates ready.
4. Provisional award/assurance letters will be issued to selected candidates shortly. The selection would be confirmed subject to verification of all original documents and fulfilment of the other eligibility requirements like Police verification, Submission of Bonds, Confirmation of admission, accreditation of college/university by Indian Missions abroad etc. as per scheme. The provisional award/assurance letter however, will not bestow any legal right on the candidate to claim the award and the award will be cancelled if any information/documents submitted by candidate is found to be false/incorrect.
5. All documents submitted by provisionally selected candidates are subject to verification for genuineness. If information/document submitted by the candidate is established as false, he/she will be debarred from the award and if he/she has availed scholarship or is availing scholarship, action will be initiated for recovery of the scholarship disbursed with 15% compound interest thereon. Such candidate is also liable to be black listed for future.
