Subject: Withdrawal of blacklisting order of NGO namely 'Manohar Bal Mandir Samiti' – reg

Sir,

I am directed to refer to your representation dated 10.10.2017 on the above – mentioned subject and to say that the same has been considered by the competent authority. In this context, it is to state that the NGO was blacklisted by this Ministry, vide order of even number, dated 16.11.2017. The competent authority directed to keep the order of blacklisting of NGOs in abeyance and to seek report from the State Government. Accordingly, blacklisting was kept in abeyance, vide letter dated 21.02.2018 and the State Government of Rajasthan was requested to conduct an inquiry and submit report to this department.

2. Government of Rajasthan, vide their letter dated 17.07.2018 submitted a detailed inspection report, along with other supporting documents, to this Ministry. The project site of the NGO was inspected by officers of Govt of Rajasthan on 17.04.2018.

3. The representation of the NGO and the Report of the Government of Rajasthan have been considered by this Department and the competent authority has decided to withdraw the blacklisting order of the organization. Accordingly, the blacklisting order of the organization, "Manohar Bal Mandir Samiti, 108, Setia Colony, SGNR Gali No. 4., Sri Ganga Nagar, Rajasthan- 335001", is hereby withdrawn. This issues with the approval of Secretary, D/o SJ&E.

Subject: Grants-in-aid to NGOs (i) " Manohar Bal Mandir Samiti ", (ii) " Nirashrit Mahila Bal Vikas Gramodyog Shiksha Samiti ", (iii) "Ankita Bal VidyaMandir" , (iv) "Gyan Deep Public School", (v) Prasadvi Sansthan under Central Sector Scheme of 'Grant-in-aid to NGO working for the welfare of Scheduled Castes' - reg

Sir

I am directed to refer to above subjects. The NGOs (i) " Manohar Bal Mandir Samiti ", (ii) " Nirashrit Mahila Bal Vikas Gramodyog Shiksha Samiti", (iii) "Ankita Bal VidyaMandir", (iv) "Gyan Deep Public School", (v) Prasadvi Sansthan have been blacklisted on the basis of inspection conducted by the Central Team vide this Ministry's order No. 11020/237/2010-SCD-III dated 16.11.2017, 11020(16)/17/2013-SCD-III dated 09.11.2017, 11020(16)/5/2013-SCD-III dated 20.11.2017, 11020(16)/1/2011-SCD-III dated 11.12.2017, 11020(16)/1/2013-SCD-III dated 20.11.2017 respectively;

2. The said NGOs were not found functioning as per the norms of the Scheme guidelines, following irregularities were found

Sl. No.	Name of NGO and date of Order	Gist of the irregularities found during inspection
1	Manohar Bal Mandir Samiti, Rajasthan 16.11.2017	Team requested the representative of Manohar Bal Mandir Samiti, Shri Chhagan Sharma, was requested to produce all the requisite records (mentioned in the prescribed proforma for inspection of Voluntary Organization working for SCs and receiving grant in aid from the M/o SJ&E for the project of residential/non-residential school/Non Residential School). However, the representative could produce only attendance register, bank pass book, salary register. He could not produce all the required records. The inspection team interviewed those students (Ms Mukhiya Dholi, Class-IV, Ms Pooja Nayak, Class-V, Mr Karambir Nayak, Class-V, Mr Aman Mandal, Class-IV, Ms Nisha Kumari Mandal, Class-V, Ms Khusboo, Mr Rajbir Singh, Class-VI and Mr Avinash Mandal, Class-II) who were identified by the representative as from the target group. All the students informed that the school is charging monthly fee. Dress and books are also being purchased from school or open market. This aspect was also confirmed from the parents of 2-3 students. Shri Balbir father of Mr Karambir Nayak, informed that he is paying Rs.1250/- per quarter, Rs.5000/- per annum, accordingly.

2	Nirashrit Mahila Bal Vikas Gramodyog Shiksha Samiti, Rajasthan 09.11.2017	The School building should be changed and have a basic infrastructure required for school like classrooms, playground etc. Proper records such as mid day meal register, stock register, uniforms & book register, doctor's visit register etc are not maintained. Other records such as attendance register, admission register are not maintained on daily basis. Poor attendance of the school students.
3	Ankita Bal VidyaMandir, Rajasthan 20.11.2017	The School authority seems to be running the school in a very lackadaisical and insensitive manner. The walls are damaged & unplastered and the same may not been repaired for quite some time. Some of the windows are without panes and covered with plastic sacks/bastas. The condition of the single toilet used for both boys and girls was unclean and unhygienic. No adequate Sports equipment were not there. No proper cooking facilities were present.
4	Gyan Deep Public School, Rajasthan 11.12.2017	Insufficient Light facilities in the classroom. Sports facilities are to be provide to students. School bags and uniforms are not provided to students. Frequency of doctors visit is not sufficient. Subsidiary accounts of Govt's grant as per GFR 150(5) were not available. Cash book, ledger, students admission register, attendance register of students and staff etc are not being maintained.
5	Prasasvi Sansthan, Rajasthan 20.11.2017	The School authority seems to be running the school in a very lackadaisical and insensitive manner. The walls are damaged & unplastered and the same may not been repaired for quite some time. Some of the windows are without panes and covered with plastic sacks/bastas. The condition of the single toilet used for both boys and girls was unclean and unhygienic. No adequate Sports equipment were there. No proper cooking facilities were present.

3. For further review, the order No. 11020/237/2010-SCD-III dated 16.11.2017, 11020(16)/17/2013-SCD-III dated 09.11.2017, 11020(16)/5/2013-SCD-III dated 20.11.2017, 11020(16)/1/2011-SCD-III dated 11.12.2017, 11020(16)/1/2013-SCD-III dated 20.11.2017 regarding blacklisting have been kept in abeyance till further orders.

4. It has been decided by the competent authority that the functioning of the above NGOs be reviewed and an enquiry be conducted by the State Government for taking an appropriate action. The copy of the Gist of the shortfalls is enclosed herewith.

5. You are, therefore, requested to conduct an inquiry on the functioning of the organization on the points mentioned above order and submit the report to this Ministry at the earliest.
