

**Minutes of Meeting of the Screening Committee held on 1.03.2019 for Selection of New Proposals of Projects under the Scheme of Assistance for Prevention of Alcoholism and Substance (Drugs) Abuse for Social Defence Services.**

The meeting of the Screening Committee of Social Defence Bureau was held on 01st March, 2019 under the Chairmanship of Joint Secretary (SD) to consider the new proposals duly recommended by the State Level Committee received from the States/UTs under the Scheme Assistance for Prevention of Alcoholism and Substance (Drugs) Abuse w.e.f. 01/4/2018.

2. The Committee comprising of Sh. S. Prakash from Manav Charities, Dr. Monika Pant and Sh. P. K. Tamarkar, Director (IFD) considered online proposals received after earlier Screening Committee held on 27.12.2018 and upto 1.03.2019. The total proposals duly recommended by States/UTs Governments received during the above period is placed at Annexure-I. Under Secretary (DP) was asked by the Committee to assist them in the scrutiny during the meeting.

3. The Committee, examined proposals state wise and district wise and decided that the new proposals should be considered only from uncovered districts subject to fulfilment of all the conditions and submission of the required documents by the organization, as mentioned in the Scheme.

4. After scrutinizing the proposals received through the concerned State Governments after their recommendations, the Committee recommended the proposals mentioned below:-






