

Minutes of the Meeting of the Screening Committee meeting held on 1st May, 2015 for scrutiny/recommending of new/review cases under the scheme of grant in aid to Voluntary Organizations working for Scheduled Castes.(Final)

The Screening Committee meeting was held on 1st May, 2015 under the chairmanship of Shri B.L.Meena, Joint Secretary (SCD-A). The two non-official members of the Committee present were (i) Dr.G.Munirathanam, Rastriya Seva Samiti, Tirupati (A.P) and (ii) Shri Amitabh Vashisha, Deendayal Research Institute, New Delhi.

2. At the outset, the Chairman informed the members about the procedure laid down in the revised scheme for GIA to Voluntary Organizations for the welfare of SCs and the financial norms that have been increased therein for the various items which has been implemented from April, 2014-15. It has been felt by the Screening Committee members that since the NGOs are not familiar with the online procedure for filing the new applications, an opportunity may be given to the NGOs for rectification of minor deficiencies noticed in their applications by the Committee within a period of one month from the date of the issue of the Minutes of the Meeting.

3. The members drew the attention of the committee to clause 2.2.i (h) of the Scheme guidelines wherein it has been mentioned that any organization or training institute of repute may also be eligible for assistance provided approval of the Secretary, SJE is obtained. Some of the reputed NGOs suggested by the members whose projects in Economically Backward Blocks (EBB) that could be considered are (i) Seva Bharti, Delhi, (ii) Mitra Niketan, (Kerala), (iii) Seva Mandir, (Udaipur), (iv) Saksham Trust, Gurgaon (Haryana) (v) Ramakrishna Mission, (Delhi) (vi) Servants of India, (UP), (vii) Gramin Shiksha Abhiyan (Punjab) and (viii) Navsarjan, Ahmedabad (Gujarat).. The Chairman informed the Committee that the proposal received from the State Government Manipur or from any of the North Eastern States of India shall have to seek clearance from the Ministry of Home Affairs if any of their case is recommended for grant of GIA under the scheme. There are 4 and 2 cases of Manipur and Nagaland respectively which were considered in the Screening Committee that may be sent to MHA for clearance. The details of such NGOs may be put up in different file. A letter to such NGOs may be sent asking them for informing this Ministry about their projects in EBB areas.

4. In this connection, the Committee was informed that as per the policy decision in the Ministry's Office Order No.1-31/2006-Cdn dated 05.09.2008

and 23.02.2009, recommendations of the State GIA Committee for new projects would remain valid for the financial year following the year in which they were received and recommendations of the Screening Committee within the Ministry would also remain valid for one year following the year in which they are recommended. The Committee was also informed that as per the Scheme, recommendations of State/UT Grants-in-Aid Committee along with inspection reports for the current year are required each and every year for releasing of grant to any project proposal under the Scheme.

5. As per the scheme guidelines, the committee adopted the following parameters for selection of new cases during the year 2014-15:-

- (i) Mandatory Recognition of the schools under the relevant statute.
- (ii) As per this Ministry's O.M. No.62-01/2007-cdn dated 27.09.2007, top priority to be given to the projects of schools. Priority for other projects is to be decided by the Committee.
- (iii) Computer education projects should be recognized by DOEACC/Universities/Accreditation bodies.
- (iv) The location of residential and non-residential school projects proposed by the organisations should be in Educationally Backward Blocks (EBBs).
- (v) As a pre-requisite, proposals are essentially required to be recommended by the State GIA Committee.
- (vi) In case of projects namely Ten Bedded/Mobile Dispensary the medical/Para medical staff engaged by the Organization should essentially have the requisite Professional qualification and furnish attested photocopies thereof, besides NO OBJECTION CERTIFICATE to run it from competent medical authority in the State.
- (vii) The deferred cases to be intimated through e-mail to the State Govt. concerned/NGOs for rectification of the minor deficiencies noticed by the Committee within a period of one month from the date of issue of the Minutes.

6. As per general guidelines for assisting Non-Governmental Organizations/Voluntary Organizations, "in order to be eligible for assistance, a voluntary organization should have been registered for a period of at least 2 years and should have been actively working in its sector for a period of 2 years. Such projects will not be taken up for assistance where the activities are proposed to commence after the project is sanctioned and funds





released by the Ministry." The NGO should also fulfill other conditions required under the scheme as per checklist prescribed in this regard.


7. In this meeting, 57 new cases/proposals received from the following State Governments were placed before the Committee for consideration.


