

MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 22nd July, 2016 TO CONSIDER NEW PROJECT PROPOSALS UNDER THE SCHEME OF INTEGRATED PROGRAMME FOR OLDER PERSONS (IPOP) FOR THE YEAR 2015-16.


The meeting of the Screening Committee of Social Defence Bureau was held on 22nd July, 2016 under the Chairmanship of Joint Secretary (SD) to consider total 285 proposals (281 proposals for the year 2015-16 and 4 deferred cases of HelpAge India for 2014-15), duly recommended by the State Level Committee received from the States/UTs under the Scheme of Integrated Programme for Older Persons (IPOP).

2. The Members of the Screening Committee, namely, Dr. G. Muniratanam, Shri Sriram Gupta and Shri Sandeep Gupta, Director (Finance), Ministry of Social Justice and Empowerment, attended the meeting.

3. At the outset, the Committee Members were briefed about the existing guidelines of the Ministry, norms and guidelines of the Scheme, budgetary allocation under the Scheme and number of new proposals received and placed before the Committee for consideration etc. The Committee was informed that the four proposals of the HelpAge India for the year 2014-15, which were deferred in the previous meeting as the representative of the organization was a Member of the Screening Committee, may also be considered.

4. Smt. Ghazala Meenai, Joint Secretary (Social Defence) and Chairperson of the Committee drew the attention of the Members that as per para 7 (ii) of the Scheme the NGO should be registered either under the Societies Registration Act, 1860 or relevant State Societies Registration Act and has already been working for at least two years. The Committee after detailed deliberations decided that the following parameters may be taken into consideration for recommending an organization to be eligible to receive grant from M/o Social Justice and Empowerment:

- (i) Priority/preference to be given to the proposals received from un-served/under-served States/Districts to ensure equal geographical spread.
- (ii) Annual Audited Accounts of the NGO to be checked to confirm that the NGO has incurred expenditure on running the project.
- (iii) Aims and objectives of the NGO should include activities for senior citizens in the MOA.
- (iv) Depending upon the geographical area and population of a District, normally 3 to 4 programmes under the Scheme should be sanctioned in a District.
- (v) Activities for care of senior citizens requires focused attention. It was therefore, decided that those organizations who are solely concentrating on welfare of senior citizens may be given preference to those who are undertaking multiple social activities.
- (vi) Proposals for Helpline and Counseling Centre were not to be recommended as this Ministry is planning to launch a national level helpline as well as District level helpline centre's for the target group. Similarly, proposals of Multi Service Centre and Day Care Centre were also not to be recommended and priority be given to the projects of Old Age Homes and Multi Facility Care Service for older widows.









5. Total 4 proposals of HelpAge India for the year 2014-15 were received from the following State Governments and were placed before the Committee for consideration. State wise number of proposals placed before the Committee and number of proposals recommended are as follows:
