

MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 30TH DECEMBER, 2015 AND 4TH JANUARY, 2016 TO CONSIDER NEW PROJECT PROPOSALS UNDER THE SCHEME OF INTEGRATED PROGRAMME FOR OLDER PERSONS (IPOP) FOR THE YEAR 2013-14 AND 2014-15.

The meeting of the Screening Committee of Social Defence Bureau was held on 30th December, 2015 and 4th January, 2016 under the Chairmanship of Joint Secretary (SD) to consider total 266 proposals (98 new proposals for the year 2013-14 and 168 new online proposals for the year 2014-15) duly recommended by the State Level Committee received from the States/UTs under the Scheme of Integrated Programme for Older Persons (IPOP).

2. The Screening Committee could not consider all these proposals on 30th December, 2015 due to paucity of time and had decided to meet again on 4th January 2016.

3. The Members of the Screening Committee, namely, Shri Mathew Cherian, Shri Sandeep Gupta, Deputy Secretary (Finance), Ministry of Social Justice and Empowerment, attended the meeting. Dr. Vinod Gupta, Member of the Committee, could not attend the meeting.

4. At the outset, the Committee Members were briefed about the existing guidelines of the Ministry, norms and guidelines of the Scheme, budgetary allocation under the Scheme and number of new proposals received and placed before the Committee for consideration etc. The Committee was also apprised of the fact that 9 projects out of 266 proposals have already been recommended by the Screening Committee in its previous meeting. Similarly, the Committee was also informed that the proposals of the HelpAge India may not be considered in the meeting as one of the Members of the Committee belongs to the organization. Similarly, Certain proposals of the organizations for RRTC have also been deferred.

5. Smt. Ghazala Meenai, Joint Secretary (Social Defence) and Chairperson of the Committee drew the attention of the Members that as per para 7 (ii) of the Scheme the NGO should be registered either under the Societies Registration Act, 1860 or relevant State Societies Registration Act and has already been working for at least two years. The Committee after detail deliberations decided that the following parameters may be taken into considerations for recommending an organization to be eligible to receive grant from M/o Social Justice and Empowerment:

- (i) Priority/preference to be given to the proposals received from un-served/under-served States/Districts to ensure equal geographical spread.
- (ii) Annual Audited Accounts of the NGO to be checked to confirm that the NGO has incurred expenditure on running the project.
- (iii) Aim and objective of the NGO should include activities for senior citizens in the MOA.
- (iv) Depending upon the geographical area and population of a District, normally 3 to 5 programme(s) under the Scheme should be sanctioned in a District.
- (v) RRTCs to be uniformly spread out and one RRTC in one State, depending upon the number of programme(s) running in the State.

- (vi) Activities for care of senior citizens requires focused attention. It was therefore, decided that those organizations who are solely concentrating on welfare of senior citizens may be given preference to those who are undertaking multiple social activities.
- (vii) Proposals for Helpline and Counseling Centre were not recommended by the Committee as this Ministry is planning to launch a national level helpline as well as District level helpline centre's for the target group.

The Committee after scrutiny of the proposals and detailed deliberations found most of the proposals were either incomplete due to deficiency of proper documents or were not meeting the requirements as per the guidelines of the Scheme of IPOP. Very few proposals were found to be complete in all respect. The proposals for Day Care Centre's for Older Persons suffering from Dementia have been recommended subject to the conditions that the NGO shall Submit medical certificate(s) from a Government Hospital that the beneficiaries are suffering from Dementia. Smt. Ghazala Meenai, Joint Secretary (Social Defence) and Chairperson of the Committee drew the attention of the Members of the Screening Committee that RRTC's to be uniformly spread out, preferably one RRTC in one State, depending upon the number of ongoing projects in the State, need to be empanelled for effective monitoring and better coordination with the Non Governmental Organizations.
