MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 11th, 24th & 25th FEBRUARY 2014 TO CONSIDER NEW PROJECT PROPOSALS <u>UNDER THE SCHEME OF</u> INTEGRATED PROGRAMME FOR OLDER PERSONS (IPOP).

The meeting of the Screening Committee of Social Defence Bureau was held on 11th February 2014 under the Chairmanship of Joint Secretary (SD) to considered total 302 fresh proposals duly recommended by the State Level Committee received from the States/UTs under the Scheme of Integrated Programme for Older Persons(IPOP) for the year 2013-14. Total 302 new proposals received by 7.2.2014 were placed in the meeting for consideration of the Committee.

2. The Screening Committee could not consider all these proposals on 11th February 2014 due to paucity of time and decided to meet again on 24th and 25th February 2014. Large number of proposals received from the States of Karnataka, Maharashtra and Orissa could not be considered by the Committee on these two days. The Committee met again on 6th March 2014 to consider the proposals received from the States of Karnataka, Maharashtra and Orissa.

3. The members of the Screening Committee, namely, Shri Mathew Cherian, Dr. Vinod Kumar and Shri Sandeep Gupta, Deputy Secretary (Finance), Ministry of Social Justice and Empowerment, Department of Social Justice & Empowerment, attended the meeting. Shri SurenderRawat, Deputy Secretary (Ageing), Shri J.K. Sahu, Under Secretary (Ageing) and Shri Sanjay Kumar, Section Officer (Ageing) were also present in the meeting to assist the Committee in the scrutiny of the proposals during the meeting.

4. At the outset, the Committee members were briefed about the existing guidelines of the Ministry, norms and guidelines of the Scheme, budget allocation for 2013-14 under the Scheme, notional allocation for the States/UTs for 2013-14 within the budgetary outlay of Rs.45.00 crore for the Scheme and number of new proposals received and placed before the Committee for consideration etc.

5. As per the existing guidelines of the Ministry release of grants-in-aid in respect of new cases which have been recommended by the Screening Committee isconsidered on receipt of State Government recommendations for the current year. No grant is released on the recommendations of the previous year. The Committee observed that many State Governments send their recommendations for release of grant-in-aid very late and mostly in the third and fourth quarter of the financial year, which cause undue delay in releasing funds to NGOs both in the cases of continuing programmes and new proposals. Accordingly, with a view to utilize the maximum funds under the Scheme, grants in aid to ongoing case are released on priority and new cases, which have been recommended by the Screening Committee earlier, are taken up for consideration thereafter. Keeping this fact in view, the guidelines for processing grants-in-aid proposals of the NGOs issued by the Cdn. Section of the Ministry vide Order dated 18.7.2013 includes, among others that the recommendation of the Screening Committee for new cases would remain valid for the following year in which they have been recommended.

6. Smt. Ghazala Meenai, Joint Secretary (Social Defence) and Chairperson of the Committee drew the attention of the Members that as per para 7 (ii) of the Scheme the NGO should be registered either under the Societies Registration Act, 1860 or relevant State Societies Registration Act and has already been working for at least two years. The Committee after detail deliberations decided that the following parameters may be taken into considerations for recommending an organization to be eligible to receive grant from M/o Social Justice and Empowerment:

- (i) Priority/preference to be given to the proposals received from un-served/underserved States/Districts to ensure equal geographical spread.
- (ii) Annual Audited Accounts of the NGO to be checked to confirm that the NGO has incurred expenditure on running the project.
- (iii) Aim and objective of the NGO should include activities for senior citizens in the MOA.
- (iv) Depending upon the geographical area and population of a District, normally 3 to 5 programmes under the Scheme should be sanctioned in a District.
- (v) RRTCs to be uniformly spread out and one RRTC in one State depending upon the number of programmes running in the State.
- (vi) Activities for care of senior citizens requires focused attention. It was therefore, decided that those organizations who are solely concentrating on welfare of senior citizens may be given preference to those who are undertaking multiple social activities.
- (vii) New programmes introduced in the revised Scheme implemented with effect from 01.04.2008 should be given due priority while considering the proposals.

7. Total 302 proposals for the year 2013-14 were received from the following State Governments and were placed before the Committee for consideration. State wise number of proposals placed before the Committee and number of proposals recommended are as follows:

8. Details of State-wise proposals showing names of the NGOs, names of the projects and remarks of the Committee are given in the Annexures attached herewith.

9. The Committee after detailed scrutiny and deliberations found most of the proposals were either incomplete due to deficiency of proper documents or were not meeting the requirements as per the guidelines of the Scheme of IPOP. Very few proposals were found to be complete in all respect. The proposals for Day Care Centres for Older Persons suffering from Dementia have been recommended subject to the conditions that the NGO shall engage an MBBS doctor who has experience in the treatment of Dementia patients and the NGO shall submit certificate from a Government Hospital that the beneficiaries are suffering from Dementia.
